Update 1

Welcome to the first of regular updates for the Local Landcare Coordinator Initiative. As you're aware the Initiative is the result of an election commitment by the NSW Government of \$15million to renew the government-community relationship and unlock the full potential of the Landcare network.

The Landcare and Local Land Services Partnership

The Initiative is significant in both its commitment of funds and also in its joint management approach. It will be collaboratively managed by Landcare NSW and the NSW Government, through Local Land Services. We are keen to make this opportunity work and to build a positive working relationship between Landcare and Local Land Services at all levels.

The collaborative efforts to get to this point have been a great example, by the many Landcare groups and networks in developing their host organisation applications and between the organisations in managing the Initiative.

Introductions

To begin we'd like to briefly introduce ourselves.

Sonia Williams has been appointed as State Landcare Coordinator working with Landcare NSW. Many of you will be familiar with Sonia through her many years of work with Landcare in many different capacities. Sonia has a detailed knowledge of Landcare in NSW. Sonia will be based with Landcare NSW working from Armidale.

Kate Andrews has been appointed as Manager Landcare Program with Local Land Services and will be based in the Batemans Bay office. Kate has worked in NRM and Landcare for over two decades in many parts of Australia. She has sat on national committees such as the Australian Landcare Council and brings an understanding of the different levels of Landcare and collaboration.

Landcare NSW will be continuing to provide support to groups and networks about employment and governance processes. They have useful resources to share and are happy to answer questions.
