

Natural Disaster Assistance Guide for Primary Producers

The impact of fires, floods and other natural disasters can affect primary producers beyond their own resilience levels, requiring assistance to recover personally and financially.

NSW Department of Primary Industries (NSW DPI) and Local Land Services (LLS) coordinate and provide recovery assistance and advice to landholders, primary producers, commercial fishers and other industries impacted by a natural disaster event.

Clean up

Before removing any waste from your property, please contact your council for disposal advice.

Be aware of dangerous trees around your property that may need to be removed.

Clean-up assistance – for assistance to clean up homes damaged or destroyed by recent fires:

Insured homeowners – contact your insurance company or the Insurance Council of Australia on 1800 734 621.

Uninsured homeowners - contact Public Works Advisory on 1800 88 55 39.

The levy for waste disposal has been waived in bushfire affected LGAs. Contact your local council for more information.

Asbestos

Asbestos dust and fibres have the potential to present a health risk during and after a fire if not properly managed.

- Asbestos clean-up and removal must be done by a licensed asbestos removalist.
- ☐ Avoid unnecessary entry, particularly entry by children.
- Asbestos debris may have been sprayed with PVA, or a similar sealant by Public Works to suppress the release of fibre until the material is safely removed.

Health & Wellbeing

From 17 January, you will be able to get Medicare benefits for up to 10 mental health treatment services if:

You or your family have been impacted by the 2019-20 bushfires

You're a first responder or emergency management employee or volunteer who worked during the 2019-20 bushfires.

You don't need to have a diagnosed mental health condition, GP referral or mental health treatment plan.

If you were affected by the bushfires, you can also get up to 10 free counselling sessions. The sessions can support you through the immediate trauma and crisis, through advice on distress interventions, coping strategies, social supports, counselling, family based psychological interventions.

Financial Assistance

IMPORTANT

- Take lots of photos as evidence of bushfire damage.
- Keep a list, or diary of activities you undertake to clean up and repair/rebuild
- · Keep all receipts and invoices
- Be aware of application deadlines
- Use the Rural Financial Counselling Service or various Support Workers to help you apply

Natural disaster assistance is available to help communities and individuals directly affected by flood, fire, storm damage or any other declared natural disaster. To support relief and recovery following a declared natural disaster a range of measures are made available by the NSW Government. These measures include:

Special Disaster Grants - Bushfire

Special disaster grants of up to \$75,000 are now available to eligible primary producers and \$15,000 for eligible small businesses and not-for-profit organisations in LGAs affected by the NSW bushfires. **Applications close 31st July 2020.**

Primary producers who have accessed all or part of the \$15,000 Category C recovery grant are entitled to access the Special Disaster Assistance Grant.

Disaster Relief Loans

Primary producers directly affected by a declared natural disaster who are in urgent and genuine need of assistance, may be eligible for low interest loans of up to \$130,000. This low interest rate loan can help a farm business to:

- continue to operate your farm businesses for the next twelve months or until the next income is received
- replace and repair damage caused to the property and associated improvements not covered by insurance.

Other support is also available for small business, not-for-profit organisations and sporting & recreation clubs.

Transport Assistance

A <u>Natural Disaster Transport Subsidy</u> is also made available to primary producers who are affected by a declared natural disaster event. The subsidy pays for the cost of transporting fodder &/or water to an affected property, stock to sale or slaughter or stock to/from agistment.

Rural Financial Counselling Services (RFCS)

The Rural Financial Counselling Service NSW provides free and impartial rural financial counselling to eligible primary producers, fishers and small rural businesses who are suffering financial hardship, and who have no alternative sources of impartial support, to manage the challenges of change and adjustment. Farm Household Support

The Federal Government Department of Human Services provides help for farmers and their families experiencing financial hardship. To be eligible:

- be a farmer or partner of a farmer, who spends a major part of your time and capital, working on the farm
- meet the income and assets test limits
- meet mutual obligation requirements.

NSW Office of Emergency Management

NSW Government Disaster Relief Grants are available for eligible individuals and families whose homes and essential household contents have been damaged or destroyed by a natural disaster.

To be eligible for this grant you must:

- be a low-income earner and meet an income assets test
- demonstrate that the affected home is your principal place of residence

- not be covered by insurance
- demonstrate that the damage was caused by the disaster
- lodge the application within four months of the disaster occurring

TAX PROVISIONS

Taxation - Profit from forced disposal or death of livestock

You can elect to spread profit earned from the forced disposal or death of livestock over a period of five years. Alternatively, you can elect to defer the profit and use it to reduce the cost of replacement livestock in the disposal year or any of the next five income years. Any unused part of the profit is included in assessable income in the fifth income year.

If you are forced to shear your sheep a second time in the same financial year there may be an opportunity to carry forward the income from the second shearing

You can elect to spread or defer profits if you dispose of stock or stock dies because

- Land is compulsorily acquired or resumed under an Act
- a state or territory leases land for a cattle tick eradication campaign
- pasture or fodder is destroyed by fire, drought or flood and you will use the proceeds of the disposal or death mainly to buy replacement stock or maintain breeding stock for the purpose of replacing the livestock
- they are compulsorily destroyed under an Australian law for the control of a disease (including bovine tuberculosis) or they die of such a disease
- you receive official notification under an Australian law dealing with contamination of property.

Loans

Drought Assistance Fund - NSW Government - Rural Assistance Authority 1800 678 593.

A \$50,000 interest-free loan to transport stock, fodder and water, genetic banking of breeding herds and installing on-farm fodder and water infrastructure. The loans term is seven years and there are no repayments required in the first two years

Farm Innovation Fund - NSW Government - Rural Assistance Authority 1800 678 593.

A loan scheme for capital works up to a value of \$1 million per project for infrastructure works (eg sheds, silos, water storage) to prepare for dry conditions, to build resilience and improve on-farm efficiency.

Subsidies

Animal Welfare Transport Subsidy - NSW Government - Rural Assistance Authority 1800 678 593.

50% subsidy of eligible costs for the permanent transport of stock off a farm which is facing financial hardship and where livestock are at fat score 2 or below (dairy cattle 3 or below), to a maximum of \$20,000 per financial year.

Donated Fodder Transport - NSW Government - Rural Assistance Authority 1800 678 593.

The NSW Government is covering the cost of transporting donated fodder when transport providers are acting in conjunction with community groups and taking fodder from within NSW to drought-affected properties. One hundred percent of the costs will be covered up to a maximum of \$5 per km and up to 1500 km.

Drought Transport Subsidy - NSW Government - Rural Assistance Authority 1800 678 593.

The NSW Government's transport subsidy can be applied to the cost of transporting fodder, water to a property for stock or household (domestic) use, stock to and from agistment, and stock to sale or slaughter. For applications received from 1 July 2019 the subsidy has expanded to include transporting of farm chemicals, fertiliser and seed to farms.

On-Farm Emergency Water Infrastructure Rebate - Federal Govt -

The Australian and NSW Governments are offering a rebate to drought affected farmers who invest in urgently-needed on-farm water infrastructure to improve productivity and resilience for horticultural farmers with permanent plantings, or that address animal welfare needs. Farmers will be able to access a 25% rebate up to \$25,000 on new purchases and installation costs of water infrastructure projects on-farm across NSW to help them in the current drought and be better prepared for future dry conditions.
