Grant Details

Landcare NSW is the state peak body for the Landcare movement in NSW.

The Landcare NSW Natural Disaster Seed Fund aims to assist Landcare NSW Member groups in re-establishing projects that have been affected by drought and bushfires throughout 2019/2020.

Funding is for an initial 'prop-ups' fund to help Landcare Member groups to re-establish their projects in disaster affected areas.

Funding is available for on-ground works only and applicants must define the impact that the natural disaster has had on their site.

Grants of up to \$1,000 are available for region ('region' defined as per the NSW Landcare Program).

This fund is administered by Landcare NSW.

Applicants must contact Landcare NSW to discuss their projects.

Projects should be relevant to the ethos of the Landcare movement in NSW and directly benefit Landcare groups and their people and places.
