Insurance Program – Hazardous Activities

Landcare NSW adopts a 'safety first' principle. We expect all paid members groups to be guided and informed by the same principle. They should also be aware and compliant with any corresponding Federal or NSW state legislation that might affect a group's activities.

Member groups are reminded that community expectation is that member group activities are held in a safe and appropriately controlled manner using every opportunity to mitigate risk to further protect groups, their members, the general public, staff and third-party contractors.

Landcare NSW regards the following activities as potentially hazardous and <u>MUST</u> be undertaken by appropriately skilled, trained, licensed, or certified individuals. Activities that are part of a controlled Landcare paid member group activity should be preapproved by the committee of management of that group.

Types of Activities:

- 1. Use of pesticides, herbicides, and other chemicals (including trailer mounted units)
- 2. Use of chainsaws, heavy and motorised machinery
- 3. Use of firearms for training purposes only*
- 4. Pest baiting
- 5. Use of watercraft (not exceeding 8m in length)
- 6. Snorkelling and scuba diving
- 7. Working at heights

Paid member groups undertaking these activities on either singular or regular basis must inform their designated contact (their groups Landcare Coordinator) or designated safety officer and operate according to both Federal and NSW state legislation.

*For the use of firearms for training purposes, the following conditions are mandatory

- 1. All training providers are third party registered firearm training providers who have their own insurance in place
- 2. All training is undertaken at appropriate training facilities managed and operated by third party
- 3. No training is provided directly by the Insured or conducted at any of the Insured location

4. A mandatory pre-event check is made to ensure that the training provider's "Certificate of Currency" are current and up to date". A copy of the "Certificate of Currency" must also be made and held on file.

All paid group members whilst participating in Landcare style group activities on public land or in a Landcare group based 'working bee' on private and/or public land, should ensure that they have appropriate certification, qualifications, and skill levels.

Furthermore, designated activity leaders and Landcare Coordinators MUST check the insurance and relevant certifications of all contractors and suppliers of pesticides/herbicides/ other chemicals that are intended to be used at the controlled activity.

All Landholder group members on which a Landcare developed project is being implemented on their own land, and who are working on their own property outside of a specific Group controlled activity, must ensure they have the correct certifications, skills and corresponding insurances to cover this work.

All Landcare group members on which a Landcare developed project is being implemented on any waterway must ensure they have the correct certifications, skills, and corresponding insurances to cover this work. As a minimum of one person must hold a current Bronze medallion (SLSA) or equivalent.

Landcare NSW will not permit untrained or unlicensed volunteers to be participating in any of the abovementioned activities.

Risk Assessment & mitigation

Paid member groups are strongly encouraged to develop a risk management strategy which could include extended insurance provision alongside other practical step that can reduce risks including site inspections or safety briefings.

It is important to include risk assessment as a standing agenda or procedure whenever activities are undertaken. The following organisations have produced an excellent practical guide to assist in developing a risk management framework.
