1.2	<ul> <li>Chairpersons Report</li> <li>The Chair's report was provided by Stephanie Cameron, with key items summarised as follows: <ul> <li>LNSW has made significant progress in the key focus areas for Landcare in the past 4 years, and we're committed to continuing to embed a culture that enables the NSW Landcare community to be even more resilient than we already are.</li> <li>LNSW new governance arrangements and constitution for Landcare NSW Limited came into effect from 1 July 2022. The new governance arrangements are a culmination of two years' worth of consultation and collaboration with the NSW Landcare community. The changes increase representative democracy and, importantly, put Landcare group members in direct control of a Board of Directors that is drawn from all parts of NSW.</li> <li>The single most important thing every group big and small, incorporated and unincorporated can do is to ensure that Landcare NSW can be an effective resource advocate for you and encourage EVERY group incorporated or unincorporated to join Landcare NSW.</li> <li>LNSW has developed exclusive opportunities to partner with organisations such as the recent \$1.3 million Partnering in Private Land Conservation project with the Biodiversity Conservation Trust, and \$5 million in funding through the Landcare Led Bushfire Recovery Grant.</li> <li>Absolutely critical has been the replication of the successful co-governance arrangements we have in place with government agencies such as Local Land Services, the Biodiversity Conservation Trust and the Department of Planning and Environment. Thank you to our key partners without them we would not be in such a good solid position.</li> <li>Publicly thanked dedicated executive committee members from the past year former vice chair Bev Debrincat, Treasurer Hunter White, former secretary Marg Applebee, Lyn Thomson, Gareth Johnston, Kathy Kelly, Georgia Rivers, Bruce Rolph, Steve Bunnell and Adrian Wells and the dedicated staff at Landcare NSW who work tirelessly to support our members and</li></ul></li></ul>	

# 1.3 CEO Report

The CEO's report was provided by Turlough Guerin, with key items summarised as follows:

- Would like to echo Chair's comments and discuss highlights and achievements. Landcare has
  never been more important or more valued. In the 2021-2022 FY we learnt a lot about how
  to adapt.
- Achievements include 60,336 trees planted as part of Creating Canopies, 35 activities
  organised by LLCs, 32 workshops as part of PPLC project, \$22.4m for current program, 23860
  reached out to an online presence during Covid, 121000 labour hours contributed through
  NSW Landcare Program, 15 riparian works through OzFish program.
- Bushfire Recovery Fund great example of LNSW working with Landcare Australia and NLN
- LNSW brought on a new Aboriginal Engagement Manager.
- The Eat Dirt program on the North Coast which continues to generate energy, excitement and hope.
- The governance program is coming to a successful and positive conclusion this year.

## 4.1 Open question time

Query regarding membership fees. Wayne Chaffey (North West) represents small group which is incorporated, with own insurance. In order to become a member they would need to pay \$550 which includes insurance. LNSW can provide membership only on case by case basis.

Question regarding Business Case from Paul Quirk (Hunter region).

Chair Stephanie Cameron provided an overview of Business Case status. Business case put together by LLS and LNSW and developed in consultation with community. Business Case has been developed over the past 12 months. It has been very well received. Pitch has been developed for new program and presented to Coalition government (Dugald Saunders), Labor (Penny Sharpe, Mick Veitch) and Greens (Sue Higginson). Currently being reviewed.

Discussion regarding components of business case and timeline of program of advocacy for local Landcare groups to approach local Members of Parliament. Plan is to reach as many parliamentarians and candidates as possible and be made aware of Landcare's achievements and need for continued support.
